

Accessibility Statement

Cimbali Group S.p.A. is committed to making its website accessible, in accordance with Legislative Decree No. 82 of May 27, 2022, implementing Directive (EU) 2019/882 on the accessibility requirements of products and services.

State of compliance

This website is ***partially compliant*** with the requirements of Appendix A of the UNI CEI EN 301549:2018 (WCAG 2.1) standard due to the cases of non-compliance listed below.

The company has taken the necessary steps to resolve the non-conformities identified, with the aim of achieving full accessibility.

Inaccessible content

The content listed below does not comply with the harmonized standard EN 301 549 for the following technical reasons identified during the audit:

Structure and navigation:

- No mechanism to skip repeated blocks, forcing keyboard users to scroll through the entire menu.
- The visual focus indicator has been removed or is imperceptible, making visual navigation via keyboard impossible.
- The hierarchy of headings on some pages does not follow a logical semantic order, skipping levels.

Interactive elements and semantics:

- Some interactive components (menu icons, search, pins on the interactive map) are made with generic elements (div, span) without semantic role (role="button") and accessible label, making them incomprehensible to assistive technologies.
- Presence of carousels that advance automatically without providing a mechanism to pause or stop the movement.
- IFrame elements lacking the title attribute, which is necessary to identify their content via screen readers.

Images and visual content:

- Decorative images have redundant alternative text instead of being ignored by assistive technologies.
- Presence of "text images" that are not readable by screen readers and cannot be resized without loss of quality.

- Infographics and photos of management lack adequate text alternatives describing their content.

Forms and readability:

- Insufficient contrast between text and background in several areas, compromising readability.
- Form fields without visible or programmatic labels, relying solely on placeholders.
- Error messages in forms are not programmatically linked to fields, and focus is not handled correctly upon submission.
- Links to PDF documents that do not specify format and size, and documents themselves are not always accessible/tagged.
